The first ENTRY DEADLINE is Friday, September 24, 2010 (postmarked date). **The fee for each entry is \$15.00 (for each instrument.) Percussion students pay one \$15.00 fee.** Please list the doubled instruments consecutively. Students that miss the first entry deadline have until Friday, October 1 (postmarked date) to meet the second entry deadline. This fee is \$45.00 for each entry. Students that miss the second postmarked deadline have until the day of auditions to enter with an emergency entry of \$100.00.

**The appropriate payment for audition fees may be by check, money order, certified funds or a valid school purchase order (purchase order requests or requisitions will not be accepted as payment). IMPORTANT: Payment of audition fees (check or purchase order) should be accompanied by a hard copy of the MSEXcel form, and must be received by the deadline date for entries to be valid. Send no cash through the mail. Certified mail with return receipt is recommended.**

Jazz Ensemble Auditions will be held Saturday, November 20, 2010 at Midwest City High School.

Audition material is posted on the OKMEA web site. No student may audition unless his director (or an OMEA member appointed by the director) is present at the audition site.
